If we increase your APRs for any other reason, we may keep them at this higher level on new balances indefinitely.</p>

We will not charge you interest on purchases if you pay your entire new purchase balance by the due date each month. We will begin charging interest on cash advances and balance transfers on the date the cash advance or balance transfer is posted to your account.
